This book presents the basic theoretical and historical concepts and it describes current perspectives and data, focusing on good practices in community psychiatry in Greece and in other parts of Europe. Concepts such as the biopsychosocial model, psychiatric reform, psychosocial rehabilitation and the recovery model, as well as new case management models are approached from a critical, anthropocentric perspective. The current socioeconomic crisis in Europe brings with it new realities in mental health systems. New forms of social suffering are forcing the psychiatric community to re-examine what is considered normal. In order to respond to the complexity of the newly emerging needs, social and community psychiatry has been compelled to broaden the objectives of intervention and research alike, developing new and dynamic relations with complementary scientific fields such as social anthropology, psychoanalysis and microeconomics. The present work is the result of collaboration between professionals from across these different fields.

In this book, Rom Harre give a state of the art overview of positioning theory via contributions from some of the world's leading experts in the field.

This book qualitatively and quantitatively examines the relationships between the constructed environment, health and social vulnerability. It demonstrates that spatial disintegration is often intertwined with health and social inequalities, and therefore a multidisciplinary approach to urban health is essential in order to analyze the impact that psycho-social-environmental factors can have on objective, and perceived health and to investigate the inequalities in healthcare and medical assistance processes. Empirical relationships have been observed between urban environment, social vulnerability and health in different contexts, however there is still a lack of standardized tools that allow us to gain a clear understanding of how health inequalities and daily life are generated. In order to address this issue, a national network of active research groups has been created to draft and develop a prototypical analysis infrastructure to facilitate empirical studies aimed at shedding light on the complex relationships between health disparities, socio-environmental and economic distress, as well as personal and collective health. Given the interest in achieving meaningful, fair and lasting solutions to health inequalities, and the current lack of an analytical system, there is the need for new multidisciplinary approaches oriented toward the quality of life within a eco-social model of health. Providing an overview of the methodological

Identities the world over have become more precarious than ever: we live in an era of constant change and disposability - whether it's last season's outfit, or car, or even partner – and our identities as a result have become transient and deeply elusive. In a world of rapid global change where national borders are increasingly eroded, our identities are in a state of continuous flux. Identity - a notion that by its very nature is elusive and ambivalent – has become a key concept for understanding the changing nature of social life and personal experience in our contemporary, liquid modern age. In this brief book, Zygmunt Bauman explains compellingly why this is so.

Over the past fifty years, (financial) capitalism has brought about an enormous growth in wealth. Millions around the world have been lifted out of poverty. However, the downsides of the present global economic constitution are rapidly becoming evident as well. Rising inequality, soaring debt levels, and repeated cycles of boom and bust have proven to be some of its key characteristics. After the 2008 crisis brought the financial system to the brink of collapse, new regulations, stricter supervision, higher capital requirements, and ethical codes were introduced to the sector. Today we find ourselves in the middle of another economic boom. Yet one pressing question remains: has anything changed? Have the (necessary) repairs fixed the flaws in the system? Or do we require even more fundamental reforms? This volume builds on the observation that society has co-evolved with the financial sector. We cannot simply claim that 'finance' was the sole instigator of the 2008 crisis. Society itself has become financialized; the

process of replacing relations, structures of trust and reciprocity, by anonymous and systemic transactions. The volume poses vital questions with regard to this societal development. How did this happen? And more importantly: is change possible? If yes, how? This volume contains 21 essays on the themes mentioned above. Authors include Jan Peter Balkenende, Wouter Bos, Lans Bovenberg, Govert Buijs, and Herman Van Rompuy. A recommendation by Dutch Minister of Finance Wopke Hoekstra is also included.

A total institution is defined by Goffman as a place of residence and work where a large number of like-situated, individuals, cut off from the wider society for an appreciable period of time, together lead an enclosed, formally administered round of life. Prisons serve as a clear example, providing we appreciate that what is prison-like about prisons is found in institutions whose members have broken no laws. This volume deals with total institutions in general and, mental hospitals, in particular. The main focus is, on the world of the inmate, not the world of the staff. A chief concern is to develop a sociological version of the structure of the self. Each of the essays in this book were intended to focus on the same issue--the inmate's situation in an institutional context. Each chapter approaches the central issue from a different vantage point, each introduction drawing upon a different source in sociology and having little direct relation to the other chapters. This method of presenting material may be irksome, but it allows the reader to pursue the main theme of each paper analytically and comparatively past the point that would be allowable in chapters of an integrated book. If sociological concepts are to be treated with affection, each must be traced back to where it best applies, followed from there wherever it seems to lead, and pressed to disclose the rest of its family.

"Climate change differs from any other problem that, as collective humanity, we face today. If it goes unchecked, the consequences are likely to be catastrophic for human life on earth. Yet for most people, and for many policy-makers too, it tends to be a 'back of the mind' issue. ... [This book] argues controversially, we do not have a systematic politics of climate change. Politics-as-usual won't allow us to deal with the problems we face, while the recipes of the main challenger to

orthodox politics, the green movement, are flawed at source." - cover. This book argues that modern technology has radically and irretrievably altered our sense of identity and hence our social, political, and legal life. In traditional societies, relationships and identities were strongly vertical: there was a clear line of authority from top to bottom, and identity was fixed by one's birth or social position. But in modern society, identity and authority have become much more horizontal: people feel freer to choose who they are and to form relationships on a plane of equality. The author examines how modern life centers on human identity seen in terms of race, gender, ethnicity, and religion, and how this new way of defining oneself affects politics, social structure, and the law. He claims that our horizontal society is the product of the mass media -- in particular, television -- which break down the isolation of traditional life and allow individuals to connect with like-minded others across barriers of space and time. As horizontal groups blossom, loyalties and allegiances to smaller groups fragment what seemed to be the unity of the larger nation. In addition, the media's ability to spread a global mass culture causes a breakdown of cultural isolation that leads to more immigration and heavy pressure on the laws and institutions of citizenship and immigration.

Sono i nostri figli a essere diventati più fragili o forse è il mondo degli adulti a nascondere i suoi diversi fallimenti sotto l'alibi di un'etichetta clinica? Quale è il confine tra un comportamento desiderabile e un comportamento anormale? In che modo la psichiatria aiuta a orientarci in questo campo? A partire dalla ricca esperienza clinica dell'autore e con moltissimi esempi tratti dalla vita quotidiana, il libro è un contributo prezioso sia per i genitori sia per gli educatori, spesso in difficoltà nel comprendere esigenze e paure dei ragazzi.

Nel dicembre 1999 l'Unione Europea riconosceva ufficialmente alla Turchia lo status di paese candidato per l'adesione, aprendo così una nuova fase nel lungo processo di integrazione turco in Europa. Circa un decennio dopo, i progressi compiuti sulla strada della democratizzazione avrebbero spinto l'AKP (Partito della Giustizia e dello Sviluppo) di Recep Tayyip Erdogan, al potere dal 2002, a fissare come obiettivo per la piena membership il 2023 – anno in cui la repubblica

fondata da Mustafa Kemal celebrerà il suo primo centenario. Da allora, il tortuoso cammino della Turchia verso l'Europa si è ripetutamente arrestato e oggi il tema dell'ingresso in UE, per quanto centrale, sembra essere stato rinviato a data da destinarsi. Ciò non solo per effetto della progressiva crisi interna dell'Unione e della recente deriva autoritaria del regime di Erdogan, ma anche a causa degli importanti mutamenti avvenuti nel frattempo sulla scena internazionale. In particolare il problema della gestione dei flussi migratori, provenienti da un Medioriente sempre più travagliato, ha assunto un peso crescente nelle relazioni bilaterali. I saggi qui raccolti, frutto di uno studio finanziato dal programma d'Ateneo di Avvio alla ricerca, offrono alcuni spunti di riflessione e proposte interpretative sull'evoluzione dei rapporti tra Turchia e Unione europea. Attraverso una prospettiva multi-disciplinare, gli autori affrontano una delle questioni più controverse e ineludibili nella storia e nel dibattito politico contemporanei, proponendone un'analisi fedele alla complessità delle dinamiche in gioco.

In che modo l'inclusione e la marginalità riguardano il mondo dell'educazione? Come si impara a includere o a escludere, a integrare o a marginalizzare, a fare i conti con le differenze, proprie e altrui? Come si possono generare nuovi apprendimenti e nuove forme di convivenza e di giustizia sociale? Sono queste alcune delle principali traiettorie che vengono tracciate nel volume, a partire dalla consapevolezza che nella contemporaneità sia indispensabile sostenere una posizione pedagogica ed etico-politica capace di confrontarsi con esse criticamente e di assumere in situazione un atteggiamento contrassegnato allo stesso tempo da rigore e creatività, tramite cui moltiplicare, rendere porosi, permeabili e attraversabili i confini che separano vita e formazione, istituzioni e territori, identità e alterità, individui, gruppi e comunità di appartenenza. Il testo è rivolto a chi, a titolo personale o professionale, ha a che fare con temi legati all'inclusione e all'esclusione.

Marialis Cultus is the title of a Mariological Apostolic Exhortation by Pope Paul VI on February 2, 1974. It is subtitled: "For the Right Ordering and Development of Devotion to the Blessed Virgin Mary," and focuses Marian devotions, clarifying the way in which the Roman Catholic Church celebrates and commemorates Mary, the mother of Jesus. The preparation of the document reportedly took 4 years. The exhortation has three parts: Part 1 discusses the history of Catholicism's Marian devotions, as well as their rationale. Part 2 focuses on what should/will take place in the Church's Marian devotions in the future Part 3 touches on the Angelus and the Rosary prayers. Marialis Cultus gives guidelines for devotions to Mary by the Church - that is, it attempts to make sure that all Marian liturgical celebrations and public expressions of devotion align with established doctrine. It noted that every element of the church's prayer life, including Marian devotions, should draw its inspiration from the Bible and harmonize with the liturgy. The conclusion to the document emphasizes the theological and pastoral value of devotion to the Blessed Virgin Mary.

In the almost 15 years since *Our Enduring Values* was published, there has been a sea change in the way much of the world thinks about and uses libraries. Destined to become another classic of library literature, this book explores such contemporary issues as The growing emphasis of the library as a cultural institution, placing libraries within their cultural context as gathering places for learning, access to information, and community The impact of technological innovations on core values such as access and stewardship Library places and spaces of the future How the mass digitization of books, archives, and other materials affects the purpose and function of libraries Intellectual freedom and privacy in the era of the PATRIOT Act, Wikileaks, and Edward Snowden The role of libraries as both champions and facilitators of social justice Inspirational yet clear-sighted, Gorman emphatically reaffirms the importance of libraries and librarians while proposing a path for future survival and growth.
